Message for service operators and service providers

Both Law no. 202/2016, which transposes Directive 2012/34, as well as the Implementing Regulation 2017/2177 require service operators and service providers connected to the CFR network and / or service providers in these facilities to provide information on access conditions and tariffs at their facilities and for the provision of services.

In accordance with Art. 5 (1) (a) of Regulation (EU) 2017/2177 this information must be included in the network reference document, through a link to a website (own website or common portal) where this information is provided free of charge.

In order to support service operators and service providers in the description of their installations and / or services, CFR SA has developed a model, presented below, which reflects all the conditions of the aforementioned implementing regulation. This template can be used by operators and service providers if they wish. This template is available in Romanian and English. The information must be published in two languages of the European Union.
