Signing contract for: Supplying the cadastral documentation and assessment of properties affected by the project of public interest "Rehabilitation of the Braşov - Simeria railway component of the Rhine - Danube Corridor, for circulation with maximum speeds of 160 Km/h; Section: Braşov - Sighişoara. Subsection 3: Caţa - Sighişoara, related to Administrative Territorial Units Caţa, Secuieni, Saschiz, Vânători, Albeşti, Sighişoara" - Lot 2

On 21 March 2017, National Railway Company "CFR" S.A. signed the service contract for supplying the cadastral documentation and assessment of properties affected by the public interest project "Rehabilitation of railway Braşov - Simeria, part of the Rhine-Danube Corridor for circulation with maximum speed of 160 km/h, section Braşov - Sighişoara, Subsection 3: Caţa - Sighişoara, related to Administrative Territorial Units Caţa, Secuieni, Saschiz, Vânători, Albeşti, Sighişoara" - Lot 2". This was done in accordance with the activities covered by the CEF grant agreement no. INEA/EFC/TRAN/M2014/1042049, project code: 2014-RO-TMC-0639-W.

The total value of the service contract is 7,303,718.40 lei, without VAT (the added VAT will be calculated according to the Romanian law). Payments under the contract will be provided by the European Commission through the Connecting Europe Facility (CEF) Transport Sector 2014-2020 and the State Budget.

The contract was awarded to Joint-Venture: S.C. Cornel & Cornel TOPOEXIM S.R.L., S.C.P. Cîmpeanu and Associates, S.C. GEOTER Project S.R.L. and S.C. THEOTOP S.R.L. and leader of J.V. is SC Cornel & Cornel TOPOEXIM S.R.L. The object of the awarded contract within above mentioned project is to supply the cadastral documentation and to assess the properties affected by the public interest project.

The cadastral documentation will be provided for the land covering a total area of approximately 2,893.7 ha, which is situated across the following territorial-administrative units of Braşov and Mureş Counties: Caţa village, Secuieni village, Saschiz village, Vânători village, Albeşti village, Sighişoara city. The evaluation process of the lands properties includes a number of 721 lands (parcels with or without buildings).

The service contract was awarded following an open procedure of public procurement with a published notice in the Romanian Electronic Procurement System (SEAP). The Beneficiary of the service contract is the National Railway Company "CFR" S.A.

The implementation period of the service contract is 215 working days from the date of its signing by both contractual parties.
